Santa Claus Inc. provided a Merry Christmas to underprivileged children in 2016 through its distribution of clothing, toys, books, blankets and quilts, and other essential items to 16,497 children. 85,000 underprivileged children received items through Santa Claus, Inc.'s year round services. Items included clothing, toys, shoes, books, bedding, personal hygiene items, underwear, socks, and school supplies.
